Full payment is required upon registration and is nonrefundable unless (1) we are able to fill your place with another participant and (2) the program has the necessary minimum required number of participants; in this case, we shall refund your fees minus a \$250 administration fee. We strongly encourage you to purchase trip insurance to cover any unforeseen events such as illness that might force you to cancel your trip. We accept Visa, Mastercard or check. If you are reserving space for more than one party, please have each party complete and return a Reservation Form with payment.

Camp price is inclusive of accommodations, tour fees, food, wine, and transportation as defined in the specific camp information. A limited number of rooms are available at the Applewood Inn on a first come, first served basis. If needed, additional rooms will be provided at the same price at another Sonoma County hotel. Transportation to all activities will be provided from both hotels.

There will be no credit or refund for partial cancellation or any unused portion of the camp. We strongly encourage you to purchase trip insurance to cover any unforeseen events such as illness that might force you to cancel your trip.

Camp price is inclusive of accommodations, tour fees, food, wine and transportation as defined in the Sonoma County Grape Camp information.

Participants are responsible for all transportation to and from the Applewood Inn in Guerneville, California.

We reserve the right to cancel the camp prior to commencement for any reason. If the camp is canceled due to insufficient enrollment, participants will be notified at least 60 days before the commencement date. In case of cancellation, full refunds will be provided.

The Sonoma County Winegrape Commission makes every effort to operate the camp as described. We reserve the right to change itineraries or substitute services of equal value without prior notice. Photos and/or videos will be taken of campers during Grape Camp for promotional purposes.
